DuperCopy aims to be a simple and easy to use tool to recover music, videos and podcasts from any iPod, iPhone or iPad.

The application is designed to run under Windows XP, Windows Vista and Windows 7 (32bit & 64bit).

If you didn't already, download the DuperCopy .zip archive here:

Before starting make sure that your system has the following items installed:

- iTunes 9.x or newer
- [Microsoft .NET framework Runtime](#) version 2.0 or higher

## Launching application

Now you're ready to launch DuperCopy, extract the .zip and double click on the DuperCopy.exe executable:



DuperCopy Libs



DuperCopy.exe

**Note:**

Do not run the application directly from the .zip file, but extract the entire content first.

From the startup window you'll be asked to connect your device if it isn't already. The application will detect your device model and briefly extract some required files.

Unregistered users will now be able to fill the activation information or continue in *trial mode* and evaluate the application functionality.

## **Trial period and activation**

---

You can evaluate DuperCopy for free having the opportunity to recover a limited number of files. We strongly suggest you to take this change and see if you're happy with the application before proceeding with purchase.

Purchasing a license is easy and secure: visit the [DuperCopy's Store](http://www.dupercopy.com/store.html) (<http://www.dupercopy.com/store.html>), review the end user license agreement and follow the simple steps to complete the payment.

You'll then automatically receive an email with the payment receipt and the activation code that will allow you to use a fully functional version of DuperCopy. You'll be asked to enter the activation code when starting the application again.

## Usage

---

Once your device has been successfully loaded, the complete content of your device library will be shown in the main window. You can browse the library by Genre, by Artist, by Album or by Playlist (if any exists) and the corresponding items will be shown in the bottom library listbox.

DuperCopy is very easy to use: select the songs/videos you want to recover from the main listbox and click on the copy button on the top toolbar. Optionally you can select some options that are covered in the Copy options section. That's it.

**Tip #1:** You can select/deselect all items by right clicking a listbox.

**Tip #2:** When no items are selected in the Genre, Artist, Album and Playlist listboxes all items in library are listed.

**Tip #3:** Use the searchbox field on top of main window to selectively search items. Advance search options are available by left clicking on the magnifying glass icon.

## Copy options

---

Copying options should suit most needs and allow to customize how files are written back to PC. You have some basic options to determine destination path and filename, and some more advanced which are listed below:

### Basic options

<i>Destination path</i>	the folder structure where the selected files will be copied to according to information found in library
<i>Destination filename</i>	the filename of the selected files according to information found in library

### Advanced options

<i>Duplicates</i>	the action taken when the destination file already exists
<i>Create Playlist</i>	when selected will create a playlist (M3U or PLS) that will contain all the selected files. The paths of files written in the playlist file can be either absolute or relative to the playlist file.
<i>Write File tags</i>	will rewrite copied files metadata (album, artist, title, etc) according to information found in library

## FAQ

---

**Q:** *I get a runtime error on startup, what should I do?*

**A:** Remember to extract the entire content of the .zip archive. Together with the DuperCopy.exe file you'll need to have a *DuperCopy Lib* folder in the same path.

**Q:** *Some file cannot be played back once copied, why?*

**A:** You do need to own the rights to playback some file formats (for ex .m4p, .m4v) and setup your PC accordingly. Refer to <http://www.apple.com/support/itunes/#authorization>

**Q:** *How do I uninstall the application?*

**A:** Simply delete the “DuperCopy.exe” file and the “DuperCopy Libs” folder
